Electric rates for residential customers



In December 2024, the Public Service Commission of Wisconsin approved Alliant Energy's 2025 Fuel Cost plan (Docket 6680-ER-104). Effective January 1, 2025, your bill will include a \$0.006269/kilowatt-hour (kWh) surcharge to reflect updated fuel costs and Alliant Energy's previously approved fuel reconciliation adjustment (Docket 6680-FR-2022). The updated fuel adjustment and electric rates effective January 1, 2025 are below.

Natural gas rates for residential customers

In December 2023, the Public Service Commission of Wisconsin (PSCW) approved new natural gas base rates effective January 1, 2025 (Docket 6680-UR-124). The average impact of the adjustment on residential customer bills is a reduction of approximately \$0.20 per month.¹ Actual costs will vary depending on your rate class and natural gas usage. At Alliant Energy, we continue to make smart investments that create a cleaner, safer and more reliable energy future. Consistent with our long-range strategic plan, these investments will increase customer value and ensure the continued delivery of cost-effective energy for years to come.
